1. INTRODUCTION

Purpose. 2. INFORMATION THAT WE COLLECT

Information You Provide to Us

We collect information you provide to us, for example when you contact us with inquiries or submit information for potential employment. This information can include your name, company name, email address and any information you include in a message or resume that you submit to us.

Information We Collect Automatically Through Your Use of our Site

Google Analytics

We use Google Analytics, a web analytics service provided by Google, Inc. ("Google") to collect certain information relating to your use of the Site. Information Collected Through Cookies and Similar Technologies

A cookie is a small file containing a string of characters that is sent to your computer when you visit a website. When you visit the Site again, the cookie allows the Site to recognize your browser. - Protect against harm to the rights, property or safety of Henniges, our users, customers or the public as required or permitted by law.

Transfer in the Event of Sale or Change of Control. If the ownership of all or substantially all of our business changes or we otherwise transfer assets relating to our business or the Site to a third party, such as by merger, acquisition, bankruptcy proceeding or otherwise, we may transfer or sell your personal information to the new owner. In such a case, unless permitted otherwise by applicable law, your information would remain subject to the promises made in the applicable privacy policy unless you agree differently.
